5.A Fire Control Room including a CCTV system will have to be maintained, which observe all floors of the building.

6.The notice of Fire Fighting and Evacuation from the building shall be prepared and displayed at all vulnerable of the building.

12.Unauthorized cooking arrangement in any floor of the building using L.P.G., Kerosene etc. shall not be permitted and Fire License shall have to be obtained for storing and processing with L.P.G. and other highly combustible articles.

13.First-Aid Fire Fighting system shall be provided as per I.S. specification.

14.Arrangement shall have to be made for regular checking, testing and maintenance of all the fire fighting installation in the building to keep them in perfectly good working condition at

16.Existing lift shall be treated as fire lift in case of emergency.

17.Periodical flashing of water from the Hydrant and Sprinkler pipe lines shall be made to maintain the efficient working performance of above mentioned system.

18.The Fire Check Door shall be sealed with rubber sealing properly in order to prevent the percolation of smoke.

19.The Fire Safety Audit to be conducted a regular interval and to be recorded in the fire prevention maintenance register.
